30	The meeting was called to order by President Ricardo R. Fernández at 3:40 p.m.
31	A motion was made and seconded to adopt the minutes of the Senate meeting of September 7,
32	
33	2011. The minutes were approved unanimously.
34	A a and Communications
35 36	 a. <u>Announcements and Communications</u>— 1. President Ricardo R. Fernández reported that in response to the Governance Committee's
37	concerns, he requested several administrators to address the Senate.
	2. Floor rights were granted for Ms. Laurie Austin, director of the Office of Admissions. Ms.
38	Austin was asked to speak about the types of outreach to attract freshmen. She reported on
39	campus visits, recruitment fairs and other enrollment related activities. Ms. Austin pointed out that
40	
41	recruitment is campus-wide effort. She thanked those who are involved and appealed to those not
42	yet involved. Discussion followed. See attachment I.

- 3. Dr. Fernández asked Provost Mary Papazian to address: lab fees, budget reductions, and the
- student evaluation of teaching tool. Dr. Papazian stated that the lab fees, which had not been
- collected in the past, are really materials fees. These fees were approved specifically for the
- departments of Chemistry, Biological Sciences and Art. The fees are set aside to help those
- departments with their needs for materials.
- 48 4. The provost also reported on the reduction in the adjunct budget. She stated that there is a
- plan in place to increase winter and summer session courses which should provide additional
- opportunities for adjunct employment. She added that there will be incentive funds for
- departments offering courses during these periods.
- 5. Finally, Dr. Papazian reported on the new student of evaluation of teaching form for students.
- The new instrument was approved by the College Committee on Faculty, Personnel and Budget
- 54 (FP&B) last spring. It was piloted in the summer sessions. She indicated that the overall return
- rate is 54%. There will be a discussion in FP&B about implementation through paper or on-line.
- 56 She asked Assistant Vice President and Associate Provost Robert Whittaker to elaborate.
- 57 Discussion followed.

- 79 2012 Regularly Admitted Students:

- **Resolved**, that the admissions standards for Fall 2012 regularly admitted freshman students,
- currently set at a minimum SAT score of 940, be modified to a minimum SAT score of 950, with
- all other admissions requirements remaining the same as those for Fall 2011.

- several abstentions. Professor Rice asked that concerned individuals e-mail their questions to her

132		1. Professor Esther Wilder and Professor Dene Hurley reported on developments in CUNY's
133		Pathways to Success Initiative. The Pathways Initiative has three elements:

	134	a. General Education Framework made up of 2 components – (i) a "Common Core" (30
	135	credits) which is common to all CUNY schools, and (ii) "College Option" (12 credits) which is
	136	specific to each CUNY senior college.
	137	b. Pathways to Largest Transfer Majors: To establish clear pathways for the largest transfer
	138	majors (identified as Accounting, Criminal Justice, Psychology, Business, Finance, Education,
	139	Biology, English Language and Literature, and Nursing), 3 to 6 courses in major or related fields
	140	will be identified and accepted as pre-requisites in all colleges that offer these majors.
	141	c. Full Course Transferability: "All courses taken for credit at an undergraduate CUNY
	142	college to be accepted for credit at every other CUNY college (though not necessarily as Gen Ed
	143	or major credit) regardless of whether a specific equivalency exists at the transfer college"
	144	2. A task force is charged with creating a 30 credit "Common Core" "by establishing learning
	145	outcomes in multidisciplinary areas." The task force is composed of 55 individuals: 16 steering
	146	committee members, who will "initiate and direct the process," and 39 working committee
	147	members, whose functions are to "advise on learning outcomes" and "communicate information
4.	148	to and from the campuses."
	149	3. The next Pathways Retreat will take place on October 14. The Pathways Committee will
	150	also present at the Professional Staff Congress on October 26. Discussion followed. See attached
